1345 Risk Register

1345.1 No issues to report.

1346 Orchard Park Playing Field

- 1346.1 It was reported that there were no maintenance issues with respect to the Playing Field.
- 1346.2 Quotes were circulated to the members of the Parish Council for repairs to the fence. It was resolved that that the quote from John Gilder at £5840 be agreed in principle subject to the obtaining of funding.

 Proposed Councillor Bishop, seconded Councillor Munday. Unanimous.
- 1346.3 <u>Action:</u> Councillor Bishop will now obtain the Enovert Trust Application Forms and investigate any other funding outlets.
- 1346.4 It was agreed that the webpage for the Playing Field Bookings would be updated and the email for Graham Spry removed. It was agreed that a booking system was not needed at present and that any inquiries for a booking should be sent to the Clerk.

1347 To update and consider any Highways issues.

- 1347.1 Thanks was expressed to Jan Davis (Flood Warden) who furnished the Parish Council with the following report and confirmed that she was having another meeting with Highways this week.
- "As the flood warden for Alstone I had been liaising with Glos Highways since October over the flooding at the road junction in Alstone. After a failed effort to clear the water, Highways visited the site and concluded that CCTV was needed to establish the crux of the problem. Unfortunately the road flooded again before this specialist resource was able to investigate. Highways came out immediately to dredge the drain on 23 December but unfortunately it was in vain as the flood returned rapidly and remained in place until the CCTV work was undertaken 11/12 January. The specialist drain team did a brilliant job, going above and beyond to get to the crux of the problem and resolve it. It transpires that the pipe from the last drain goes underground all the way into the ditch adjacent to the playing field and in places had been completely blocked with vegetation. Given the locations of further drain covers that were identified and the immediacy of the situation there was no opportunity to close the road, which led to a few disgruntled drivers and one complaint to the drain company. There are a couple of residual issues to be resolved but the junction should now be problem free, at least for a few years!"
- 347.3 Councillor Munday confirmed she had spoken to the Road Safety Officer but he confirmed that there was little hope reducing the speed limit but highways would look at additional signage to slow traffic. Any further measures such as speed cameras would be a cost to the Parish Council and it was agreed that such a cost was not within the PC budget.

1348 The A46 Group (TAAG)

1348.1 TAAG gave the update.

1348.2 Public Consultation The non-statutory public consultation for the proposed route options was cancelled in Autumn 2022. Gloucestershire County Council (GCC) said that it would now take place once additional analysis had been completed, which could take 9 months, in late 2023 at the earliest (dates tbc). Councillor Vernon Smith has now advised us that GCC wish to bring forward the public consultation to Summer 2023. This has not been confirmed yet and is subject to budget agreement by the Full Council at their next meeting on 15th February 2023. He plans to produce a newsletter which will include an update on this, which he hopes will be out by the end of February.

We asked Councillor Smith if this meant that the costs were increasing again but he said he didn't know until he saw the papers ahead of the meeting. The agenda and papers should be available a week ahead of

until he saw the papers ahead of the meeting. The agenda and papers should be available a week ahead of the meeting i.e. 8th February and TAAG will be reviewing these for mention of the public consultation as well as any cost implications.

1348.3 Tewkesbury 'Bridge over Rail' and Tewkesbury Garden Town. We have heard just today that the Court of Appeal has overturned Tewkesbury Borough Council's decision to permit plans to develop a road bridge over the railway in Ashchurch and Northway. This bridge was considered "....critical to the success of the overall development plan in the area.....", so what with this set back as well as the permission for 500 houses to be built near Bredons Hardwick also being refused by Wychavon District Council, it's not clear where this leaves the Tewkesbury Garden Town, nor what impact this will have on the proposed bypass and A46. Also, this decision means the borough council will be required to pay Ashchurch Rural Parish Council's legal costs, which are anticipated to be £70,000. The total cost to the council, including its own costs, is expected to be over £200,000!

1348.4 TAAG will be producing an update for residents with more information as soon as this is available.

1349 To discuss possible coronation celebrations/volunteering event.

1349.1 It was not to take any action on this matter and to support the Village Hall events.

1350.1 To discuss the replacement of defibrillator pads.
